Investors can register, the following types of companies for starting the operations in the Fujairah Free Zone Authority as per the requirements.

- Free Zone Establishment (FZE) an entity with sole owner.
- Free Zone Company (FZC) an entity owned by 2-5 partners.

New business entities can have two types of Branches.

- A branch of the company registered in the United Arab Emirates.
- A branch of the company registered outside the United Arab Emirates.
